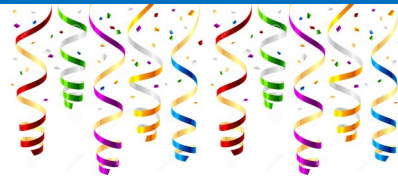

You may be wondering why the Chaplain hasn't been wandering around the Home these past few months. Here's the reason:

Chaplain's Corner

Back in July ~ September 2021, I was at the VA and in the planning stage for having knee replacements. When they did the pre-op testing they found my blood counts to be abnormal. They sent me to Dartmouth-Hitchcock where I received the diagnosis of acute myeloid leukemia (AML). This is a chronic leukemia which requires treatments for extended periods now and into the future because this cancer leaves a residue of cells that can not be detected. So... treatments must continue regularly.

As we Christians do, I immediately asked God to take my burden. I am confident that God will get me through this. There have been some other bumps in the road as well, such as pseudo-gout in my knees and blood clots in my left leg and right lung. He has held my hand every moment and has had His angels (doctors, nurses, specialists) as well as family, friends and neighbors who have called, sent cards, prayed and been there for me. Praise God for all these very special folks.

I am very weak due to the cancer infusions and all the medicines, but I am getting around with a walker or wheelchair. God has me on a positive ramp to become fully restored and in good condition. He is awesome. Sometimes, there is no strength to stand up, that's where God adds his strength to stand and off we go. Even in discomfort and pain, God's presence and strength leaves me with a sense of joy and peace.

Enough about me, I surely miss not being able to visit you folks, to meet the new Veterans, spouses and new staff. But praise God in due time I'll return to normal. Thinking about you folks often. Congrats to Ruth on her 100th Birthday!! Wow!!

It will be great to get back to the Chapel and to bring God's messages to you all. And maybe soon you all will be able to come to the Chapel for Mass and All-Faiths services.

Remember, God causes all things to work together for good to share with those who love Him, to those who are called according to His purpose.

God bless you all and please pray for our troops everywhere.
